Secretary-General Welcomes Progress in Talks on Zaire

Following is the statement of Secretary-General Kofi Annan concerning the negotiations in South Africa on the future of Zaire, issued today in Geneva by the Spokesman travelling with the Secretary-General:

I welcome the news out of South Africa today that the first direct talks on the future of Zaire established a positive working relationship between the parties, as well as the outline of a transition process to a peaceful and democratic Zaire.

The next step is to agree on a cease-fire. I urge the forces of the Alliance of Democratic Forces for the Liberation of Congo/Zaire (ADFL) and those of the Government of Zaire to firm up their stated commitment to a total cessation of hostilities and I urge the nations of the region to support this effort.

I am encouraged that the parties reaffirmed their support for the United Nations/Organization of African Unity (OAU) peace plan and committed themselves to transparent, fair and inclusive elections to bring about democratic change in Zaire.

I hope that the political family of Zaire will now work together to build a peaceful future. If they do so, the world will applaud their courage, and the entire region would benefit.

Secretary-General stresses need for cease-fire, sustained talks on Zaire's future

The following statement was issued today by the Spokesman for Secretary- General Kofi Annan:

While I am pleased that the parties to the conflict in Zaire have accepted the five-point peace plan endorsed by the Security Council, I am concerned that its implementation has not yet begun in earnest. There is no firm cease-fire.

Mohamed Sahnoun, the joint United Nations/Organization of African Unity (OAU) Special Representative for the Great Lakes Region, has energetically pursued a peaceful and democratic transition in Zaire. I thank those countries that have supported his efforts; but more needs to be done.

I, therefore, appeal to all Member States to press Laurent Kabila and his supporters in the Great Lakes region to seek a negotiated solution through a cease-fire and sustained talks on the future of Zaire. I am also encouraged that President Mobutu Sese Seko has agreed to a dialogue with Mr. Kabila. A durable solution cannot be achieved through military means.

It is obvious that Zaire is on the verge of major political change; but this change has to be managed, with the support of the international community, in a concerted and focused manner. In such situations, progress is usually made when the entire international community comes together.

The stakes are high. If we are successful, Zaire could begin to move in the direction of national reconciliation, democracy and prosperity. If we fail, it will mean misery and stagnation for millions of people in the region.

Secretary-General encouraged by developments in eastern Zaire

The following statement was issued today by the Spokesman for Secretary- General Kofi Annan:

The Secretary-General is encouraged that Laurent Kabila travelled to Kisangani over the weekend to take personal charge of the grave humanitarian situation involving Rwandan refugees in eastern Zaire.

He is also pleased that Mr. Kabila pledged to cooperate with the United Nations High Commissioner for Refugees and other humanitarian agencies to resolve the problem.

These agencies will need the support of Mr. Kabila, and that of his Alliance, to locate and gain access to the refugees, gather them to points where they can receive aid and be secure, and eventually repatriate them to Rwanda. The Secretary-General and the entire international community are counting on that support for a successful relief operation and will continue to monitor the situation closely.

Daily Press Briefing of the Office of the Spokesman of the Secretary-General 5 May 1997

Juan Carlos Brandt, Associate Spokesman for the Secretary-General, reminded correspondents at the start of today's briefing that the Spokesman's Office had issued the following statement over the weekend:

"The Secretary-General is gratified that President Mobutu Sese Seko and Laurent Kabila have begun a dialogue on a peaceful transition of power in Zaire.

"He is grateful to President Nelson Mandela, Ambassador Bill Richardson and the other heads of State for helping launch this dialogue. He also wishes to thank Mohamed Sahnoun, the joint United Nations/Organization of African Unity (OAU) Special Representative for the Great Lakes Region, who worked tirelessly over the past three months to lay the groundwork for the talks.

"But the work of managing this process of change has just begun. The Secretary-General calls on all the principal players in Zaire, as well as on all interested States, to continue to work together to assure a successful completion of the process, leading to peace, democracy and prosperity in Zaire."

Mr. Brandt then said that the communiqué read by Mr. Sahnoun at the conclusion of those talks was available in the Spokesman's Office in English and in French.

He then announced that a total of 2,606 Rwandan refugees had been repatriated today. Some 10 planes had left Kisangani to Rwanda. A total of 7,500 persons had been repatriated to Kigali, Cyangugu and Gisenyi. After the tragic incident that lead to 91 refugees being crushed to death in the train and some 50 wounded yesterday, the Office of the United Nations High Commissioner for Refugees (UNHCR) had decided not to send the train back to Biaro.

However, Mr. Brandt continued, the rebels of the Alliance of Democratic Forces for the Liberation of Congo-Zaire (ADFL) were sending trucks loaded with refugees without any control by UNHCR staff. Trucks capable of carrying a maximum of 50 passengers were being loaded with 100 or more. The UNHCR had no control over how and where the trucks were being loaded. Living people were being dumped near corpses off the trucks. The situation was getting "worse by the minute", he said. Some 6,000 refugees had been brought to the Kisangani transit centre overnight; between 30,000 and 40,000 refugees were concentrated in Biaro, and additional refugees were emerging from the surrounding forest bearing "fresh wounds", he said.

An atmosphere of panic was prevailing in Biaro, leading to stampedes and chaos when food was distributed.

The UNHCR needed access to the refugees, but that access was largely being denied by the forces of the Alliance, Mr. Brandt said. The UNHCR was not being allowed to enter Biaro today, and the agency had no control over how repatriation was being carried out. "They need access to those refugees if they are to perform this daunting task", he said. "If we don't want to see more people dead, we need to get to them. We need to be given the means, the access and the permission to organize repatriation." The present situation was "totally unacceptable", he stressed.

Mr. Brandt then announced that a press release on the United Nations Joint Investigative Mission for Eastern Zaire was available in the Spokesman's Office. The release stated that human rights investigators had arrived in Kigali and were ready to begin their work, pending clearance from the Alliance. In a presidential statement on 24 April, and again on 30 April, the Security Council had called on the Alliance and other concerned parties to cooperate fully with the Mission, he recalled.

The Mission was established by a resolution of the Commission on Human Rights on 17 April, he said. It comprised the Special Rapporteur on the human rights situation in Zaire, Roberto Garretón; the Special Rapporteur on extrajudicial, summary and arbitrary executions, Bacre Waly Ndiaye; and a member of the Working Group on Enforced or Involuntary Disappearances, Jonas Foli. The Mission is supported by human rights, information and security officers from the United Nations Secretariat and by a five-member team of forensic experts from Argentina. Concerning the announcement of last Friday regarding the report of the Secretary-General on the situation in Western Sahara, Mr. Brandt said the report was still being drafted and would be submitted to the Secretary-General for his approval, prior to its presentation to the Security Council on Friday, 9 May.

Report of the Secretary-General on the Situation in Burundi

S/1997/547

I. INTRODUCTION

1. On 30 May 1997, in a presidential statement on Burundi (S/PRST/1997/32),the Council requested me to continue to keepit informed on the situation in Burundi, especially with regard to thesteps being taken to encourage a negotiated and peacefulsettlement of the ongoing conflict in that country.

2. The present report covers the main developments that have occurred since the previous report to the Council on 2November 1996 (S/1996/887/Add.1). It will be recalled that, since the adoption of resolution 1072 (1996) of 30 August1996, the Council has continued to receive regular briefings on the situation in Burundi.

II. POLITICAL SITUATION

3. During the period under review, the political situation in Burundicontinued to reflect the deep divisions within and betweenthe country's leading political movements, the polarizing influence of militant extremist groups at both ends of the political spectrum, the adverse effects on the security situation of events in formerZaire, Burundi's efforts to end international isolationbrought about by the sanctions, and the lack of an agreed mechanism fornegotiations acceptable to all the principal actors. Forits part, the Government of President Pierre Buyoya continued efforts to consolidate power, to secure the lifting of economicsanctions and to encourage political dialogue, while stepping up efforts to combat the growing Hutu insurgency and themounting death toll.

4. Divisions within the two main political parties, their rivalry and theconstraints imposed on their work by the Government, have continued to feed animosities. The Front pour la démocratie au Burundi (FRODEBU), led in Burundi by itsSecretary-General Augustin Nzojiewami and in exile by its Chairman JeanMinani as well as the Conseil national de défense dela démocratie (CNDD) leader Leonard Nyangoma, seems unable to overcome its internal divisions. The same is true of theUnion pour le progrès national (UPRONA), which remains factionalized between the followers of the Chairman of theUPRONA parliamentary group, Frédéric Ngenzebuhoro, and those of theextremist wing led by Chairman Charles Mukasi. These divisions are exacerbated by the hard-line Parti pour le redressementnational (PARENA), led by former PresidentBagaza, who continues to enjoy strong support among Tutsi youth andstudents.

5. The continuing hostility between political parties continues to preventprogress in the national debate advocated by theGovernment, and to hamper international efforts to bring the parties to thenegotiating table. Extremists on both sides continueto disrupt reconciliation efforts by threatening and undermining thePresident. Anti-Buyoya sentiments culminated in mid-March1997 with the discovery of an assassination plot against the President.Swift action against the alleged perpetrators resulted inlarge numbers of arrests. Former President Bagaza is still under housearrest and members of his PARENA party are stilldetained.

6. On a more positive note, and despite these troubling developments, therestoration of the National Assembly in September1996 has increasingly provided a forum for more regular political activityand dialogue among politicians of the differentfactions. Although the Assembly itself remains ineffective and has lostmuch of its original influence on the political process, asnoted in the previous report, it was able nonetheless to carry out somevaluable work. The Speaker of the National Assembly,Mr. Léonce Ngendakumana, still has a crucial role to play in efforts toharmonize relations among the various segments of thepopulation, particularly as the Assembly continues to be challenged by thedeep-rooted antagonism between its two mainparliamentary groups - UPRONA and FRODEBU. In closing the Assembly'sordinary session in June 1997, the Speakerwelcomed the fact that most of its members were able again to participate to return from exile. However,in order for the Assembly to fully carry out itsconstitutional responsibilities a number of obstacles have to be resolved. They include putting an end to the judicial harassment of the Speaker and providing the Assembly with the necessary financial andlogistical support for its regular work.

7. A further positive development was the re-emergence on the politicalscene of former President Silvestre Ntibantunganya, who on 7 June 1997, left his refuge at the residence of the United StatesAmbassador in Bujumbura, after securing assurancesfrom the Government of his freedom and security. Mr. Ntibantunganya pledgedhimself to strive to civilize the political debate inBurundi and to contribute to the normalization of political life in thecountry. He also declared his readiness to join peace talkswith a view to ending the civil war between the armed opposition and thearmy. It is hoped that Mr. Ntibantunganya's presencewill have a positive impact on efforts to achieve party and nationalreconciliation.

III. SECURITY SITUATION

8. Since November 1996, the security situation has continued to be affected both by political developments inside Burundi andby military and political developments in the subregion. At the end of 1996, rebel attacks and army counter-operations led to aseries of violent clashes throughout the country - but particularlyconcentrated in the northern provinces of Cibitoke, Bubanza,Muramvya and Kayanza, where violent incidents claimed a large number of victims among the civilian population. The situationin and around the capital, Bujumbura, remained tense and very volatile.

9. With the advance of the Allied Democratic Forces for the Liberation of the Congo (ADFL) in eastern Zaire and the consequent elimination of rear bases of armed Hutu rebels close to the Burundi-Zaire border, the security situation in Burundigradually improved during the first

months of 1997, though strong pocketsof rebels remained within the former Zaire (now theDemocratic Republic of the Congo) near Fizi, Kalemie and Moba - enablingthem to launch operations against targets inBurundi, including the Government's military strongholds of Bururi andMakamba provinces. Overall, however, the massivemovement of Hutu rebels along the western shores of Lake Tanganyika andacross the Lake into the United Republic ofTanzania ultimately caused a shift in rebel operations towards the south. The resulting rebel infiltration from the United Republicof Tanzania into the southern provinces of Burundi caused a rift betweenthe two Governments, with accusations that theUnited Republic of Tanzania was not only harbouring rebels but actively supporting the insurgency. These accusations havebeen denied by the Government of the United Republic of Tanzania.

10. In March 1997, the areas in and around Bujumbura increasingly becametargets of rebel attacks. Mine explosions causeddozens of victims as did counter-insurgency operations by the military - asituation aggravated by the detection of anassassination plot against the President (see para. 5 above). Another verydisturbing incident occurred on 1 July 1997 when alandmine exploded under the car of the Speaker of the National Assemblywhich was carrying his wife and a bodyguard. Whilethe wife of Mr. Ngendakumana escaped unharmed the bodyguard died.Meanwhile, faced with an enormous increase in rebelactivity in the south of the country, the Government decided to establish aspecial crisis committee dealing with security issues.Reports were also received from Rumonge commune in Bururi province, ofallegations that rebels had killed more than 145people.

11. Fierce clashes between the rebels and army units continued to shakeBurundi in April, accompanied by claims andcounter-claims on the responsibility for the killing. In one particularlyvicious incident - attributed to the rebels - 34schoolchildren and seven teachers were killed in an attack at a secondaryschool in Buta, south of Bururi. In May, heavyfighting continued in the southern provinces, causing international aidagencies to evacuate their staff. Violence also flared upagain in the north-west where rebels attacked regroupement camps (see sect.V below) in Murwi and Buganda, killing some63 people. Throughout May and June, fierce fighting was reported close toBujumbura, including the slaughter on 14 May1997 of 42 persons at a church in Muhuta commune. On 3 June 1997, the armyused mortars and aircraft to rocket rebelpositions near Bujumbura, following severe battles with rebels on theoutskirts of the capital.

12. As the violence continued unabated throughout the month of June,rumours were spread by the rebels that neighbouringcountries were preparing to invade Burundi in support of the currentregime. Military sources, in contrast, claimed that therebels wanted to establish a bridgehead on Burundi territory in order topress forward their rebellion with the support of theinternational community. Throughout the period under review, reports alsocontinued to be received of increased faction fightingamong the Hutu rebels - between the Parti pour la libération du peuple hutu(PALIPEHUTU) and the armed wing of CNDD.Reports were also received that former soldiers from the ex-FAR (Forcesarmées rwandaises), members of the Interahamwemilitia and even former soldiers of the ex-Zairian army were involved inattacks alongside Hutu rebels in north-western Burundior caught in clashes on their way from eastern Zaire back into Rwanda. Inresponse, regional and military officials fromnorthern Burundi and southern Rwanda agreed in principle to cooperate onsecurity matters and to extradite each other'srebels. Although bilateral security arrangements could not be confirmedofficially, it is apparent that supportive arrangements continue to be carried out in the border areas between the two countries.

IV. HUMAN RIGHTS

13. The number of people detained on suspicion of involvement in massacresand of supporting the armed Hutu rebels has risento some 5,000. After an interruption of a few months, the criminal courtsbegan to function again on 26 February 1996. Manyof the first trials were conducted without proper legal representation of the accused, despite demands from defendants fordefence lawyers to be made available. Owing to the social and politicalsensitivities and pressures inherent in the trials, manyBurundian lawyers declined to undertake representation of such defendants, and increasing calls were made for assistance from the international community. The first trials in 1996 resulted innoticeably heavy sentences, including 133 death sentences and54 life sentences. Only 36 acquittals were obtained during the initialround of trials.

14. Faced with demands for counsel to be provided for the accused, theBurundi Justice Ministry - in collaboration with theNational Bar Association, the United Nations Centre for Human Rights, theOffice of the Special Representative of theSecretary-General in Burundi and various local human rights organizations -discussed ways in which financing might beobtained for the employment of national and international lawyers who wouldassist accused persons in obtaining counsel. Atthe end of 1996, following these discussions, a judicial assistanceprogramme was established by the Office of the UnitedNations High Commissioner for Human Rights, in cooperation with theGovernment of Burundi. Implementation of the projectbegan immediately, thereby facilitating the opening of the first session of the criminal courts in February 1997. In April and May1997, the second session of the criminal courts was held in the presence of international lawyers who collaborated with nationallawyers in acting as defence counsels or as civil party lawyers. Aremarkable reduction in the sentence levels has been noted, with only 13 death sentences and 10 life sentences so far being recorded, in addition to 14 acquittals.

15. The atmosphere of the initial trials, which had been tense and subject o strong public pressure, has gradually given way to more calm and dispassionate environment. The presence of lawyers at theside of the accused has helped to reduce tensions and promote greater attention to legal requirements. Many of the cases under consideration extended beyond the expected time-frame, as postponements enabled some defendants to prepare a better defence, while the absence of witnesses complicated and delayed the trials of others.

16. With respect to the administration of justice, however, it must also benoted that the situation of these defendants remains inmarked contrast to that of the suspected authors of the attempted October1993 coup - most of whom remain free. Only a fewwere apprehended during the hours after the coup, and while some have fledto other countries others remain in Burundi.Although public opinion continues to demand their arrest, many continue togo about their usual business with apparentimpunity.

17. A significant, though largely symbolic, step was taken with the commencement by the Buyoya Government of criminal proceedings against 79 military officers accused of having fomented the October 1993 coup. On 16 May 1997, the prosecution opened its case, alleging that the group had been responsible for the death of President Melchior Ndadaye, the first democratically elected Hutu President of Burundi. The accused proclaimed their innocence and the proceedings were adjourned. The trial resumed on 4 July 1997, with the accused providing additional testimony, after which the case was again adjourned. No date has been set for the resumption of the proceedings. While the commencement of proceedings against the 79 officers is an important first step, much more will be required if the administration of justice in Burundi is to regain genuinecredibility.

18. On 14 June 1997, President Buyoya publicly called for the establishmentof an international criminal tribunal for Burundi, inorder to try the instigators and perpetrators of acts of genocide thatfollowed the October 1993 coup. In response to a recentletter addressed to me by the Government of Burundi on the creation of aninternational tribunal, I replied that given the circumstances prevailing in Burundi I was not in a position to recommend to the Security Council the establishment of such atribunal at the present time. It is my intention to remain seized of thematter, however, and to review the question of the stablishment of such a tribunal at a later date. I will, of course, keepthe Council fully informed of developments in this regard.

V. HUMANITARIAN SITUATION

19. The extensive fighting in the north and south of the country hasdisplaced a significant proportion of the population andmade it difficult for humanitarian aid agencies to conduct a consistent and effective relief programme. At the same time, landmines have become an increasingly pervasive source of danger to aidworkers and civilians alike. Nyanza Lac in the south, which has recently suffered an outbreak of cholera, has not been accessible United Nations aid agencies because of fighting in the area. Therefore, the humanitarian situation in Burundi remains, despite the easing of sanctions, extremely serious owing to two main factors, namely, the high degree of insecurity in the country and the concentration of the rural population from conflict-prone areas into regroupement camps.

20. Regroupement, the policy of collecting people in camps, an exercise initiated by the former Government in March 1996, accounts for over 300,000 persons living in sites or camps. The number of people displaced by fighting and insecurity amounts more than 350,000. According to recent estimates, the number of vulnerable persons in rural areas now totals some 700,000. Out of a population of an estimated 6 million, approximately one out of nine Burundians lives in a camp, often in poorsanitary conditions.

21. Repeated displacement of rural populations, together with the existence of regroupement camps in areas often remote fromfamily agricultural production areas, has severely disrupted agricultural production as well as the distribution of agricultural products. This situation has been greatly exacerbated by the sometimes deliberate destruction of fields and livestock by thewarring protagonists. Significant environmental damage has also occurred insome areas as a result of deforestation by refugees and displaced persons, and also acts of sabotage. In January

1997, a jointFood and Agriculture Organization of the UnitedNations (FAO) and World Food Programme (WFP) assessment mission to Burundifound that food production had declinedby an estimated 18 per cent during the first agricultural season of 1997compared with pre-crisis levels.

22. Humanitarian agencies have been pressing the Government of Burundi toreverse its regroupement policy on humanitariangrounds, and to facilitate wider access to vulnerable groups in order torelieve the country's dire humanitarian plight. TheGovernment of Burundi has also been persistently pressed by the broaderinternational community to dismantle the existing regroupement camps. On 28 May 1997, I wrote to President Buyoya expressing my own concern about these camps and urging him to take concrete actions to start phasing out those in secureareas. The President replied that regroupement was not policy but a temporary measure to ensure the safety of people in certainareas of the country. He reaffirmed his pledge todismantle the camps located in areas where relative security has again beenattained. However, only one small regroupementcentre has been dismantled to date. The intention of some provincial officials to dismantle camps only to create smaller onescloser to the homes of the regrouped have caused consternation among theaid community and led many observers to conclude that the Government is unlikely to fully abandon the regroupement policy in the foreseeable future. The United Nationscontinues to provide humanitarian assistance to regroupement camps but onlyon the basis of assessed needs and under strictmonitoring.

23. As far as refugees are concerned, about 130,000 have returned since1996. While many of these refugees have returnedspontaneously to safe areas in Burundi, the Office of the United NationsHigh Commissioner for Refugees (UNHCR) reports that 150 to 200 are fleeing daily from the Bururi and Makamba provinces to the United Republic of Tanzania out of fear ofbeing caught in the fighting in these provinces.

VI. MEDIATION EFFORTS

24. National and international political mediation efforts have continuedthroughout the period under review, and although someimportant positive developments have taken place, a significantbreakthrough has yet to be achieved. Mediation efforts havefollowed three linked but distinct tracks: the ongoing regional mediationeffort led by former Tanzanian President Julius K.Nyerere; the talks between the Government and CNDD under the auspices of the San'Egidio Community in Rome; and themore recent United Nations and Organization of African Unity (OAU) decisionto appoint a Joint UN/OAU SpecialRepresentative for the Great Lakes Region.

25. Former President Nyerere remains the principal international Mediatorfor the conflict in Burundi, and the focal point forinternational efforts to achieve a ceasefire and bring about comprehensivepolitical negotiations among the parties. A cessation of hostilities in Burundi has continued to be a matter of high priority for the international community, while the Government of Burundi has repeatedly stressed the need to reassess the economic sanctions of the country. At a meeting in Lomé, during the course of the Summit Meeting of the Central Organ of the Organization of African Unity Mechanism for ConflictPrevention, Management and Resolution, held on 26 and 27 March 1997,President Buyoya made the case for lifting thesanctions. To all of his interlocutors, he conveyed his strong belief thatsanctions not only hurt the more vulnerable segments of the population but also hindered national reconciliation and strengthened the extremists.

26. Ahead of the Fourth Arusha Regional Summit, which was to be convened on16 April 1997 to review economic sanctionsagainst Burundi, former President Nyerere took the initiative to inviteBurundi political parties for another round of talks.Although several parties welcomed the initiative, others expressed lack ofconfidence in the Mediator and declared that no talkswere possible unless economic sanctions were lifted. The Arusha Summitiself, attended by President Buyoya, called upon theGovernment of Burundi and all the parties to the conflict to take steps tourgently create the necessary environment fornegotiations and national reconciliation. The Summit also decided to easesome of the sanctions and agreed on the need toensure the speedy and efficient implementation of the exemptions providedfor humanitarian assistance. The participantsdeclared their readiness to suspend all sanctions once there was movementin the negotiations.

27. At a follow-up meeting on 10 May 1997 in Kampala, no agreement wasreached on the list of products to be exempted from the regional sanctions regime. At the end of June, the Government of Burundi expressed its disappointment that sanctionshad still not been eased, and its concern that the embargo was exacerbating tensions in the country. On 27 June, the Government of Kenya decided to lift the fuel and travel embargo against Burundi, for humanitarian reasons. A number of countries in Central Africa are gradually lifting the embargo as well.

28. While discussions on sanctions and their possible relaxation were goingon, representatives of the Government and CNDDwere engaged, with the blessing of Mwalimu Nyerere, in direct secret talksunder the auspices of the San'Egidio Community inRome. Despite a difficult start and after various problems had beenovercome, the two-party talks concentrated on the need tostop the fighting in Burundi and to secure a permanent ceasefire. On 10March 1997, both parties agreed on the broad agendathat should guide their talks. The agenda included the following items:

(a) The restoration of constitutional and institutional order;

(b) Issues related to the Burundi armed forces and police;

(c) The suspension of hostilities;

(d) The administration of justice, including the creation of an international criminal tribunal to try acts of genocide and political crimes;

(e) The identification and involvement of other parties in the negotiation process;

(f) A permanent ceasefire;

(g) Guarantees for the respect and the implementation of the agreement.

29. The public announcement on 13 May of the agreement and confirmation of the secret talks between the Government and CNDD drew harsh criticism from many sectors of Burundi society, across the political spectrum. Those not represented inRome felt excluded from the discussions, which they felt should have takenplace in a wider, multi-party environment. Tradeunions, student organizations and some political groups condemned the talksout of fear that concessions made to the Hutuopposition, particularly CNDD, might compromise their own political viability. Opposition to the process begun in Rome hascontinued to mount among extremists and has compelled President Buyoya toengage in an intensive campaign throughout thecountry. By contrast, reactions from the opposition were more positive. TheSpeaker of the Assembly took a strong position infavour of the Government.

30. On 21 May 1997, President Buyoya wrote to former President Nyerereoutlining the various steps the peace process inBurundi should follow and asking him to organize as soon as possible allparty negotiations under the Mwalimu's auspices. Healso reaffirmed his readiness to work closely with him to organize thesenegotiations. Efforts by the Mediator to convince thevarious political parties to accept all-inclusive political talks under hisaegis have yet to succeed. In preparation for thesemulti-party talks, which are now scheduled for the end of July, formerPresident Nyerere dispatched on 5 July a mission toBurundi to take stock of the political situation and encourage all partiesconcerned to participate in the negotiations.

31. In order to consolidate the ranks of those who are for peace, it isimperative that opportunities for dialogue and debate, both within civil society and between political parties, be created andpromoted. In this connection, I have instructed the UnitedNations Office in Burundi to support all initiatives aimed at promotingpeace and reconciliation among the population, including the national debate and the activities of the Speaker of the Assembly. In this regard, it is important to mention that the UnitedNations Office has played a constructive role in promoting dialogue and reconciliation among the major political actors, particularly during tense periods, and has maintained good working relations with the Government and the Parliament. It has kept me fully informed of the major developments in Burundi. As Iinformed the Security Council on 25 June, I intend tostrengthen this Office by the appointment of a senior official and oneadditional political affairs officer, in order better to support the peace process in Burundi.

32. In support of the efforts of the Mediator and of the process begun inRome, the Security Council on 24 January 1997approved a joint proposal from myself and the Secretary-General of theOrganization of African Unity, Mr. Salim A. Salim, toappoint Ambassador Mohamed Sahnoun as our Joint Special Representative forthe Great Lakes Region, with priorityattention to be given to Congo (ex-Zaire) and Burundi. Ambassador Sahnoun, who has visited Burundi several times, continuesto follow events in that country very closely. He developed a relationshipof trust with many of the actors inside and outsideBurundi and particularly with President Buyoya, with the Speaker of theParliament and with former President Ntibantunganya.He played a very important facilitative role on the eve of the FourthArusha Summit. In addition to meeting with MwalimuNyerere and President Mkapa in Dar es Salaam, Ambassador Sahnoun consultedin Arusha with President Buyoya and withall the parties who

were present there. His contributions have been appreciated by all.

VII. OBSERVATIONS

33. President Buyoya's determination to pursue all-inclusive negotiationshas resulted in improved relations between theGovernment and those who are interested in advancing a negotiated andpeaceful settlement of Burundi's conflict. I amparticularly encouraged by the new willingness shown by President Buyoyaand his Government to cooperate with a variety of international actors in order to help find solutions to Burundi'spersistent problems, and by the gradual rapprochement between the President, the Government and the National Assembly. Should thesepositive trends continue, Burundi will be able toestablish the conditions necessary for the further easing of sanctions. Thestubborn and unrelenting opposition to any kind of political settlement must not be allowed to close the promising window of opportunity that has opened.

34. The efforts of former President Nyerere to induce the differentpolitical parties to meet at the negotiating table will continue receive my full support. Despite the difficulties and reservations expressed by certain parties, it is clear that he will continue to play an important role in promoting a comprehensive settlement of the conflict in Burundi, since he enjoys the confidence of the Heads of State of the region. With the appointment of the Joint UN/OAUS pecial Representative for the Great Lakes Region, I hope that new impetus will be given to efforts by the international community to address the underlying causes of conflict and instability in Burundi.

The following statement was issued today by Secretary-General Kofi Annan:

I deplore the radio and television broadcasts in the east of the Democratic Republic of the Congo which falsely accuse the United Nations High Commissioner for Refugees (UNHCR) of arming Rwandan refugees.

The UNHCR has a consistent policy of humanitarian action around the world. It has never been involved in the provision or supply of arms to any refugee groups. The charges are completely without foundation. I reiterate my full confidence in the High Commissioner and in UNHCR staff in the region, who have performed with great courage and distinction in extremely difficult circumstances.

I call upon those who are behind this unfounded anti-UNHCR media campaign to cease their false accusations, which could have a serious effect on the work and well-being of innocent humanitarian workers in the region.

Expresses Appreciation to President Kabila, U.S. Ambassador Richardson

This statement was issued today by the Spokesman for Secretary-General Kofi Annan:

The Secretary-General wishes to refer to the joint Press Statement issued by the United States Special Envoy, Bill Richardson, and the Minister for Reconstruction and Emergency Planning of the Democratic Republic of the Congo, Etienne Richared Mbaya, in Kinshasa on 25 October, in connection with the Investigative Team appointed under his authority to investigate the serious violations of human rights and international humanitarian law alleged to have been committed in the Democratic Republic of the Congo since March 1993.

At the press conference on the same day, President Laurent-Desire Kabila confirmed the Government of the DemocraticRepublic of the Congo's commitments contained in that Statement which builds on the Secretary-General's letter to President Kabila of 15 July setting forth the Team's mandate.

These public statements represent a breakthrough in the impasse which has confronted the Investigative Team in its efforts to fulfil its mandate. The Secretary-General congratulates Ambassador Richardson for this significant achievement.

On 29 October, Ambassador Richardson met the United Nations High Commissioner for Human Rights, Mary Robinson, inGeneva. At that meeting, Ambassador Richardson appraised the High Commissioner of the discussions in Kinshasa and other capitals in the region and the Government of the Democratic Republic of the Congo's commitments regarding theimplementation of the mandate of the Investigative Team. Ambassador Richardson advised the High Commissioner that hisdiscussions in Kinshasa and the joint Press Statement confirmed the mandate of the Team as set out in the Secretary-General's letter to President Kabila on 15 July.

The Secretary-General wishes also to express his appreciation to President Kabila for his public statement committing hisGovernment to cooperating with the Investigative Team in a way which will allow the Team to carry out the mandate entrusted to it.

The members of the Team are currently en route to Kinshasa to pursue their investigation. * *** *

Secretary-General postpones for 48 hours decision on withdrawal of Congo investigative team

The following statement was issued today by the Spokesman for Secretary- General Kofi Annan:

I can confirm that this morning the Secretary-General was on the verge of pulling out his human rights investigative team from the Democratic Republic of the Congo.

He had sent the team to Kinshasa on 24 August, but they were not allowed to deploy into the field. He recalled them to NewYork for consultations. He sent them back to Kinshasa on 11 November, following an agreement with the Governmentbrokered by United States Ambassador to the United Nations, Bill Richardson. There was no movement. He received a report from the team yesterday indicating there was still no progress, which triggered his decision to withdraw.

He was informed today by the United Nations Ambassador of the Democratic Republic of the Congo that a meeting had been set between the team and President Laurent Kabila tomorrow in Kinshasa, as well as with Etienne-Richard Mbaya, the head of the Liaison Committee that is to facilitate the work of the team. After consulting several Member States, he agreed to postpone his decision for 48 hours, to see if the obstacles raised by the Government would finally be lifted.

The Secretary-General feels he cannot justify much longer retaining the team in Kinshasa, if it cannot move into the field immediately to conduct the investigations it was sent there to carry out.

I have the honour to refer to the situation in the Great Lakes region and Central Africa, and to the need to adjust the United Nations political presence in that region to the new environment brought about by the momentous changes that have taken place there since the beginning of the year.

As you know, the United Nations contribution to the regional mediation concerning Burundi and to the international peace initiatives which accompanied the changes of regime in the Democratic Republic of the Congo and the Republic of the Congo has been largely carried out by Mr. Mohammed Sahnoun, in his capacity as Joint United Nations/Organization of African Unity Special Representative for the Great Lakes Region of Africa. His mandate was outlined in my letter of 22 January 1997 to your predecessor (S/1997/73) and endorsed by the members of the Security Council (S/1997/74).

I wish now to seek the Council's concurrence with a new mandate for Mr. Sahnoun in Africa, as well as for a new political and humanitarian presence for the United Nations in the Great Lakes region, in the person of my former Special Envoy for Sierra Leone, Mr. Berhanu Dinka.

As my Special Envoy in Africa, Mr. Sahnoun will continue to follow closely developments in Central Africa, including the Great Lakes region. He will also lend his support to existing peacemaking and peace-building initiatives there, and give special attention to Burundi. In addition, he will be available for preventive and other missions that I may ask him to undertake in other regions of Africa as needed. Mr. Sahnoun will operate on an as and when employed basis. I estimate the cost of his mission as my Special Envoy in Africa at US\$ 890,000 for the biennium 1998-1999.

Mr. Sahnoun could not have carried out his difficult assignments over the last 11 months without the generosity of those Governments who have made funds available for his mission through the Special Fund set up in support of his efforts. To those Governments, I wish to express here my deep gratitude.

As for Mr. Dinka, he will serve as my Representative and Regional Humanitarian Adviser for the Great Lakes Region.

In his capacity as my Representative, Mr. Dinka will represent me in meetings held in the region, monitor developments and their implications for peace and regional security, and seek to contribute to regional efforts in the prevention or peaceful settlement of conflicts.. With specific regard to Burundi, he will oversee the political activities of the United Nations in that country, and support ongoing political initiatives for Burundi both inside and outside the country. In carrying out the above functions, Mr. Dinka will consult my Special Envoy in Africa as required.

In his capacity as Regional Humanitarian Adviser, Mr. Dinka will represent the Emergency Relief Coordinator in the Great Lakes region, facilitate the coordination of humanitarian assistance, support the Resident Coordinators, Humanitarian Coordinators and agency heads, and coordinate resource mobilization efforts at the regional level.

He will set up an office in Nairobi with a complement of three Professionals, two internationally recruited General Service staff, one Security Officer, and three locally recruited staff. The total estimated cost of the Office of the Representative of the Secretary-General and Regional Humanitarian Adviser for the Great Lakes Region is approximately US\$ 3 million for the biennium 1998-1999.
